

# Intellectual Property Terms and Conditions

## 1. Introduction

Welcome to ReadySetSent (the "Platform"). These Intellectual Property Terms and Conditions ("IP Terms") are part of the Agreement between you ("User" or "you") and ReadySetSent ("ReadySetSent," "we," "us," or "our"). By accessing or using the Platform, you agree to comply with these IP Terms.

## 2. Definitions

In these IP Terms, the following terms have the meanings set out below:

"Platform" refers to the online reverse auction platform provided by ReadySetSent, accessible at [\[Platform URL\]](#).

"User Content" refers to any content, information, or materials uploaded, posted, or otherwise made available by Users on the Platform.

"Intellectual Property" refers to any and all proprietary rights, including but not limited to patents, copyrights, trademarks, trade secrets, and any other legally protectable intellectual property.

## 3. Ownership of Intellectual Property

You must have the legal right to use, display, reproduce, and distribute any Intellectual Property contained in your User Content.

(b) Users must not use the Platform to engage in or facilitate any form of intellectual property infringement, including but not limited to copyright infringement, trademark infringement, or patent infringement.

## 5. Reporting Intellectual Property Infringements

- ii. Sufficient information to identify the location of the content on the Platform.
- iii. Your contact information.

(b) We will respond promptly to investigate and address valid intellectual property infringement claims.

ReadySetSent may, at its sole discretion, terminate or suspend the accounts of Users who repeatedly infringe upon the intellectual property rights of others.

ReadySetSent reserves the right to update, modify, or change these IP Terms at any time. Any changes will be posted on the Platform, and your continued use of the Platform after such modifications signifies your acceptance of the updated IP Terms.
